



2	INSTRUCTIONS TO BIDDERS	Delete the last sentence in Paragraph 5. <u>EXPLANATIONS</u> , and replace it with the following: "No response will be made to inquiries received by the District less than ten (10) Days before the scheduled Bid Opening."
3	INSTRUCTIONS TO BIDDERS	Delete the second sentence in Paragraph 6.B. <u>Pre-Bid Protests</u> , and replace it with the following: "Five (5) copies of pre-Bid protests must be received by the District Secretary's Office no later than ten (10) Days prior to the Bid opening."
4.	SUPPLEMENTARY CONDITIONS Article SC7.4	Delete the first sentence in General Conditions Article GC7.27.3, and replace it with the following: " GC2.27.3 The Bidder that meets the SB Subcontractor participation goal will be eligible for a preference of 5% of the Bid Price of the lowest responsible Bidder, up to a maximum of \$1 million, only during evaluation for determining the award of the Contract."
