- Schedule Update schedule to reflect scope modifications and current market conditions.
- ii. Package 2 Develop new package, incorporating packaging comments from BART for the scope of work to be constructed by BARTCCD. This package will consist of:
 - Drawings Update drawings based on current design showing work to be performed by BARTCCD and retitled for Package 2.
 - Specifications Develop a new set of specifications based on applicable sections from the current design and retitled for Package 2. No changes to the specifications other than updates to title sheets, and sections' headers and footers are anticipated.
 - Engineering Cost Estimates Prepare new cost estimate for the scope of work included in Package 2 and updating unit rates per current market conditions.
 - Schedule Update schedule to reflect scope modifications and current market conditions.
- Bid Support As requested by BART, provide bid support during procurement of Package 1.
- Packaging Coordination Coordinate drawings with disciplines and BART as required for packaging only. No design revisions are anticipated from review comments.
