

## OFFICIAL RULES: BART BIKE BINGO CONTEST

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

Entry: To enter, visit [bart.gov /bartable](http://bart.gov/bartable) and follow the instructions to complete the BART Bike Bingo board. To play, ride BART and take photos to complete a blackout (all spaces covered) or a row (up, down or diagonally, like Bingo). Place your photos in a collage (you can use free apps such as PicCollage; PhotoCollage; or Fotor). Submit your photos to [bartable@bart.gov](mailto:bartable@bart.gov) or upload to Twitter with the hashtag #BARTBikeBingo by 11:59 PDT, June 1, 2015. If you submit your entry by Twitter, make sure your tweet is public and you follow @SFBARTable so we can contact you if you win. Public libraries have free internet access. By completing and submitting the contest registration during the promotion period, each participant will earn one (1) contest entry. Limit of one (1) entry per participant during the promotion period.

1. Sponsor is San Francisco Bay Area Rapid Transit District (BART), P.O. Box 12688 (LKS-18) Oakland Ca 94604-2688.

2. Eligibility: This Contest is open only to U.S. legal residents who are 18 years of age or older at the time of entry. Employees and agents of Sponsor and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Contest. 3. Awarding of prizes: Around June 2, 2015, sponsor will award \$30 worth of BART tickets and two BART pant straps to the first 10 people who submit a completed BART Bike Bingo card. The next 20 people who submit a completed BART Bike Bingo card by 11:59 PM PDT, 6/1/15 will receive a BART pant strap. The time stamp of when the email was sent to [bartable@bart.gov](mailto:bartable@bart.gov) or when a tweet was posted will be used to determine the contest winners. Potential winners will be notified by email or direct message on Twitter by June 5. If potential winner does not respond within two (2) business days, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate winner will be selected via next time stamp.

4. There are ten (10) grand prizes, which are comprised of \$30 worth of BART tickets and two (2) BART pant straps. There are twenty (20) first prizes, which are comprised of one (1) BART pant strap. No prize substitutions or cash equivalent of prize is permitted.

5. Submittals become property of BART and they may be publicized/published without compensation.

6. General: Contest is subject to applicable federal, state and local laws. Entrants agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. By

entering this Contest, entrants expressly acknowledge that these Official Rules have been drafted in the English language, and that any translation prepared for any reason will be of no legal effect and the English version of these Official Rules shall govern any dispute. By participating, contestant releases and agrees to hold harmless Sponsor and its respective promotional partners, parents, affiliates, subsidiaries and agencies and their directors, officers, employees and agents from any and all liability for any injury, death, loss, tax liability or damage of any kind arising from contestant's participation in this Contest or resulting from entrant's acceptance, possession, use or misuse of the prize.
