Intro to Redistricting

- Redistricting is the process of adjusting district lines every 10 years after the release of the US Census
- Federal (Congress), State, and Local government
- Goal: Create population-balanced districts for equal representation





Federal Voting Rights Act

• Section II, Federal Voting Rights Act of 1965

"Prohibits discrimination on the basis of race, color, or membership in a language minority group" – justice.gov





California Voting Rights Act (AB 182)

"...prohibits the use of an at-large election in a political subdivision if it would impair the ability of a protected class, as defined, to elect candidates of its choice or otherwise influence the outcome of an election."

- BART has implemented district-based elections to meet this requirement.





California Fair Maps Act (AB 849)

- Districts shall be geographically contiguous
- Maintain geographic integrity of neighborhoods or communities of interest
- Minimize the division of cities or census designated places
- Easily identifiable by natural and artificial barriers
- Geographic compactness





Supplemental Information

- Population-balanced districts
- Districts shall not favor or discriminate against a political party
- Existing BART district boundaries provide a baseline for demographic analysis
- Voting laws, data, community input





Community Engagement

- Critical element of the redistricting process
- Public hearings to enable community participation
- Community-based organizations
- Community outreach website, social media platforms, community venues, etc




