If the successful Bidder finds that the actual BART Support amount required to complete the project exceeds the estimated amount found in the Bid Schedule, the Contractor shall reimburse the District for the full actual amount, including the amount in excess of the estimated amount. If the successful Bidder finds that the actual BART Support amount required to complete the project is less than the estimated amount, the Contractor shall only reimburse the District for the actual BART Support amount.


