Grant of Easements for the Purple Lotus Temple in the Cities of Union City and Fremont

<u>PURPOSE</u>: To request that the Board authorize the grant of easements across a portion of BART Parcels O-AB74, O-AB94 and O-AD28 (Fox Avenue) in the Cities of Union City and Fremont, to the Purple Lotus Temple, the City of Fremont, Pacific Gas and Electric, and the Alameda County Water District, respectively.

DISCUSSION: The District granted Mission Peaks Homes an easement for construction, maintenance, repair and replacement of a private road across a portion of Fox Avenue on March 7, 1991. The Purple Lotus Temple purchased the property served by the easement from Mission Peaks Homes on July 16, 1999, and now wishes to develop the property. Development is contingent, however, on the grant of additional easements from BART within the existing easement area to three agencies. An easement for emergency vehicle access is required by the City of Fremont (Sheet 1 of Exhibit A); Pacific Gas and Electric (Sheet 2 of Exhibit A) requires an easement for a gas line; and the Alameda County Water District (ACWD) (Sheet 3 of Exhibit A) requires an easement for fire hydrants and appurtenances, and to connect to an easement previously granted by BART to ACWD. Staff has determined that there should be no charge for the three easements because the original easement granted to Mission Peaks Homes in 1991 was intended to include utilities and emergency access. The agencies now require that the easements be granted directly to them.

In addition, the Purple Lotus Temple is requesting an underground storm drain easement connecting the existing private road easement to the public storm drain system. The original 1991 easement to Mission Peaks Homes did not anticipate underground storm drainage. The easement is approximately 5,236 square feet (Sheet 4 of Exhibit A) and within an area of Fox Avenue already encumbered by easements that BART granted jointly to ACWD and East Bay Regional Park District in 2002. Staff deems the requested easement to be of a nominal value (\$5,000.00).

All easements will require the issuance of a BART permit (except emergency vehicle access) prior to any construction to ensure that there are no conflicts with BART Operations.

BART staff has determined that there will be no significant effect on the environment from granting these easements and that the action is exempt from the provisions of the CEQA pursuant to CEQA

Guidelines Section 15061(b)(3).

The Office of the General Counsel will approve the easements as to form.

<u>FISCAL IMPACT</u>: BART will incur no costs in granting the four easements. The Purple Lotus Temple will be paying \$5,000.00 for the storm drain easement, along with fees for the reimbursement of staff time, pursuant to the Board- adopted Fee Schedule and deposited in General Fund 030.

<u>ALTERNATIVE</u>: Not convey the requested easements, which would impact the ability of the Purple Lotus Temple to develop their parcel.

Award Contract No. 15PU-110 for 34.5kV Cable System Upgrade KMA, CRO, and RAS Substations Tie-In

NARRATIVE:

Purpose:

To obtain Board authorization for the General Manager to award Contract No. 15PU-110, for 34.5kV Cable System Upgrade KMA, CRO and RAS Substations Tie-In, to Shimmick Construction Co., Inc.

Discussion:

This Contract is the first of three contracts funded under the BART Earthquake Safety Program to upgrade BART's 34.5kV subtransmission system which supplies power to the traction power system. Currently, the 34.5kV subtransmission system is divided into sections for the C-Line, R-Line, and a section that combines the K-Line and the A-Line. Currently, the three sections are not connected to each other. This could have a serious consequence in a catastrophic event, such as a large magnitude earthquake, that could, for example, cause power disruption to the southern section of the R-Line and the Rockridge Station on the C-Line. Upon completion of the work in Contract No. 15PU-110, the three sections will be connected and this would allow the District, upon a power fail on the R-Line or C-Line as in the above example, to supply power to these failed sections with power from the K/A-Line section, thus allowing revenue service to be restored on BART's Core (operability) system.

In addition, the cross-connection of the K/A, C, and R-Line sections will provide flexibility in the 34.5kV subtransmission system by allowing any single section to be supplied, at least partially, from any of the other two sections.

Advance Notice to Bidders was mailed on March 24, 2011, to 162 prospective bidders as well as to 22 Plan Rooms and Minority Assistance Organizations. The Contract was advertised on March 29, 2011.

A Pre-Bid Meeting was held on April 14, 2011 and attended by eleven (11) prospective bidders. A total of twelve (12) firms/plan holders purchased copies of the Contract Documents.

A matchmaking session was held on May 2, 2011 and attended by seven (7) prime prospective

bidders and seven (7) subcontractors that were interested in pursuing subcontracting opportunities with the prime contractors.

A total of eight (8) Bids were submitted and publicly opened on June 21, 2011.

After review by District staff, the apparent low Bid submitted by Shimmick Construction Co., Inc., has been deemed to be responsive to the solicitation. Furthermore, staff's review of the Bidder's business experience and financial capabilities has resulted in a determination that the Bidder is responsible and that the Bid of \$6,645,000 submitted by Shimmick Construction Co., Inc. is fair and reasonable. It is 30% lower than the Engineer's Estimate of \$9,500,000.

Pursuant to the District's Non-Discrimination in Subcontracting Program, the availability percentages for this Contract are 23% for Minority Business Enterprises (MBEs) and 12% for Women Business Enterprises (WBEs). Shimmick Construction Co., Inc. committed to 67.3% MBE and 32.7% WBE. The Office of Civil Rights has determined that the Bidder has exceeded both MBE and WBE availability percentages for this Contract.

FISCAL IMPACT:

Funding for \$6,645,000 for award of Contract No. 15PU-110 is included in the total project budget for 15PU000, ESP 34.5kV Retrofit Work. The Office of the Controller/Treasurer certifies that funds are currently available to meet this obligation.

As of June 27, 2011, \$42,490,000 is available for commitment from the proceeds of the General Obligation Bond for this project, with \$32,490,000 tracked in Fund 801F and \$10,000,000 tracked in 801J. BART has expended \$2,435,481 and encumbered \$222,832 to date. There are

no pre-encumbrance in BART's financial management system. This action will encumber \$6,645,000 leaving an available fund balance of \$33,186,687.

There is no fiscal impact on available unprogrammed District Reserves.

ALTERNATIVE:

The Board may decline to authorize award of this Contract. If the Contract is not awarded, the upgrading of the 34.5kV subtransmission system will be delayed, retaining the vulnerability of losing traction power to certain sections of the system after a catastrophic event such as an earthquake. The ability to interconnect the 34.5kV subtransmission system is essential in providing normal revenue train operations without delay after a catastrophic event. The Board may also elect to reject all Bids and authorize staff to readvertise. This would result in additional cost and time and is unlikely to yield lower bids.

RECOMMENDATIONS:

It is recommended that the Board adopt the following motion.

MOTION:

The General Manager is authorized to award Contract No. 15PU-110, for 34.5kV Cable System Upgrade KMA, CRO and RAS Substations Tie-In, to Shimmick Construction Co., Inc., for the Bid amount of \$6,645,000, pursuant to notification issued by the General Manager, and subject to the District's protest procedures.

SUBJECT: Assistance in Redistricting of Election Districts

The Redistricting Special Committee recommends that the Board of Directors engage the services of a qualified consultant to assist in the adjusting of the District's election district boundaries.

The purpose of this project is to redistrict the election districts of the San Francisco Bay Area Rapid Transit District in accordance with the requirements of the District Act and based upon the population data resulting from the 2010 United States Census. The Board of Directors must adjust the boundaries of the election districts by November 1, 2011. The consultant's responsibility will be to assist the Board of Directors to complete this task in an accurate, efficient, and timely manner.

A Request for Proposals (RFP No. 6M1043) was advertised on April 29, 2011. Notices of availability of the RFP were mailed to 94 potential proposers, including 53 Disadvantaged, Minority, and Woman-owned Business Enterprises. Two proposals were received on May 17, 2011, from the following proposers: Sandi Polka Consulting, Rescue, CA (a District certified Woman-owned Business Enterprise); and ARCBridge Consulting & Training, Inc., Herndon, VA (a U.S. Small Business Administration certified Small Disadvantaged Business).

District staff reviewed the proposals for compliance with the requirements of the RFP and found them to be satisfactory. The Sandi Polka Consulting proposal was determined to be the most advantageous for the District considering cost and other factors (prior redistricting and mapping experience, proposed project staff, familiarity with the Bay Area region).

Staff advises that pursuant to the District's Non-Discrimination in Subcontracting Program, the availability percentages for this contract are 16% for MBEs and 20% for WBEs. Sandi Polka Consulting did not meet the MBE percentage; however, it is a certified WBE and will be performing 46% of the work. Based on the review of the information submitted by the proposer, the Office of Civil Rights found no evidence of discrimination.

The funds required for the agreement are included in the Office of the District Secretary's Operating Budget for Fiscal Year 2011-2012.

The Redistricting Committee recommends that the Board authorize the General Manager to execute an agreement with Sandi Polka Consulting to provide consulting services for assistance in redistricting of election districts, in an amount not to exceed \$139,000.00.
