  - d. Concord (Intermodal/Balanced)
  - e. Fruitvale (Balanced/Urban w/parking)
  - f. Hayward (Balanced/Urban w/parking)
  - g. Castro Valley (Auto Dependent/Intermodal)
  - h. Powell (Urban/Urban)
  - i. Glen Park (Urban w/parking/Urban)
  - j. San Bruno (Intermodal/Balanced)
- D. Next is to do site visits and find gaps
- E. Will result in a list of improvements and rough cost estimates
- F. Measure RR has money to improve access – combine BART money with city/count money for safe routes to transit improvements
