2. Public Comments

Danny Kodmur mentioned he attended August's BATF meeting and today will be his second meeting. He mentioned he is interested in joining the BATF.

Hillary Brown stated she is interested in joining the BATF. She mentioned this will be her third meeting that she has attended.

Annie Koruga shared correct pronouns are they/them.

Alex Tiphayachan expressed concerns that BART will no longer be selling group BART magnetic striped tickets when he teaches youth, seniors, and students with disabilities how to navigate through BART System and riding AC Transit bus system.

3. Approval of August 24, 2023 meeting minutes

Daveed Mandell moved approval of the August 24, 2023 meeting minutes with amendments. Clarence Fischer seconded the motion.

4. BART Accessibility Improvement Program – Phase 2

Ahmad Rassai (AR) presented on, "BART Accessibility Improvement Program – Phase 2."

AR introduced himself and he is the Accessibility and Improvement Program Manager. AR mentioned the purpose of the Accessibility Improvement Program (AIP) is to improve accessibility in and around the BART stations and to better meet

the needs of the disabled community and added the goal is to enhance access and safety in and around BART Stations.

He listed project locations at these BART stations.

AR went over Accessible Improvement, Phase 2 estimated schedule for exterior work and interior work from 2023 to 2024.

He explained exterior work entails accessible ramp corrections, accessible paths and bus pad slope corrections, and cross walk stripping.

AR explained interior work entails handrail corrections, replace existing courtesy phones with Americans with Disabilities Act (ADA) compliant phones, and lighting upgrades at elevator lobbies at some BART Stations.

He went over a diagram of a street ramp that is Americans with Disabilities Act (ADA) compliant and would like to see ADA street ramps to be consistent throughout the BART system.

AR mentioned some handrails at BART Stations will be replaced with new ADA compliant handrails under the exterior work agreement.

He shared handset courtesy phones will be replaced with hands-free courtesy phones throughout the BART System.

Roland Wong addressed lighting concerns at South Hayward BART Station and Ashby BART Station. He said South Hayward BART Station is dark throughout the station and should add this issue to the list of improvements. He mentioned at the Ashby BART Station, the lighting at the platform level is very dim and brighter lights should be installed. AR mentioned South Hayward and Ashby BART Station are on his list for future AIP projects with lights and wayfinding signs.

Don Queen asked what does, "AIP," means. AR clarified it stands for, Accessible Improvement Program.

Don Queen stated some of the Braille Tactiles signs are too low and wishes they are located at an average human height so he does not have to bend over to touch the Braille Tactiles.

Daveed Mandell agreed with Don Queen that the location Braille Tactiles are inconsistent and stated Braille Tactiles should be metal instead of plastic.

AR mentioned federal funds have specific guidelines that BART has to follow on how the money is used. Federal funds has to be for corrective Americans with Disabilities (ADA) actions.

5. Nominations and Elections for Chair, Vice-Chair, and 2nd Vice-Chair

Elena Van Loo and Bob Franklin led agenda item, "Nomination and Elections for Chair, Vice-Chair, and 2nd Vice-Chair."

Chairperson election:

Randall Glock was nominated as Chairperson and he accepted.

Randal Glock gave a short speech as to why he would be a good candidate as Chairperson.

Roland Wong was nominated as Vice-Chairperson and he accepted.

Roland Wong gave a short speech as to why he would be a good candidate as Vice-Chair.

2nd Vice-Chairperson election:

Clarence Fischer and Janice Armigo Brown were nominated for 2nd Vice-Chairperson and both accepted.

Clarence Fischer gave a short speech as to why he would be a good candidate as 2nd Vice-Chair.

Janice Armigo Brown gave a short speech as to why she would be a good candidate as 2nd Vice-Chair.

Voting results for 2nd Vice-Chairperson:

Elena Van Loo announced the new Chairperson is Randall Glock, Vice-Chairperson is Roland Wong, and 2nd Vice-Chair is Janice Armigo Brown and they will serve for one year.

6. New committee member nomination

Randall Glock led the agenda item and introduced Bruce Yow who is interested in becoming a BATF member.

Bruce Yow introduced himself and expressed why he is interested in joining the BATF.

Clarence Fischer moved to recommend Bruce Yow as a BATF member. Roland Wong seconded the motion.

Motion passes with nine (9) in favor, zero (0) against, and zero (0) abstention

7. Discuss new BART September 2023 service changes

Randall Glock led agenda item, "Discuss new BART September 2023 service changes."

Clearance Fischer mentioned he heard from people with disabilities and senior communities that they feel they are being discriminated against, especially on the Fremont and Dublin/Pleasanton lines which have six car trains. He stated people with disabilities and seniors attempt to board the trains during commute hours, some in wheelchairs, some in other mobility devices and they have been denied boarding due to the trains being packed. Clearance Fischer mentioned BART is monitoring the number of shorter trains since September 11, 2023 and may need to re-look into extending the number of trains during commute hours.

Director Robert Raburn shared BART is monitoring and depending on ongoing commute during commute hours, the number of trains can increase. He mentioned the shorter trains were to prevent anti-social behavior.

Roland Wong mentioned he has been going to San Francisco more often and has noticed the middle cars have been more packed with riders with their bikes and expressed he worries that he may catch COVID or a flu. He strongly advices to go back to ten car train during peak time.

Catherine Callahan agreed with what has been said and added the crowding on the trains really concerns her and hopes this new train service changes will be monitored. She mentioned she is a wheelchair user and entering and exiting the trains with the new train service changes has been a challenge.

Daveed Mandell mentioned he is blind and finds the six car trains to be too short. He stated he is being pushed into or trying to get around him if he's standing near the doorway and expressed his white cane, which he uses to navigate, may get damaged due to overcrowding. He says going back to eight car trains or going back to ten car trains is best thing to do.

Emily Witkin said since having shorter trains, even during non-peak hours, the trains can be too crowded heading towards to San Francisco.

8. Member Announcements

Clarence Fischer mentioned he still uses his paper discount BART tickets and mentioned as of November 30th, 2023, paper discount BART tickets will no longer be able to be used at the faregates. He asked why this was not a public announcement so people are aware of this change, deadline.

Daveed Mandell shared that Paratransit should provide same day service and making reservations twenty-four hours in advance is not acceptable.

Catherine Callahan suggested to have BART staff come to the meeting to present.

9. Staff Announcements

Bob Franklin introduced and welcomed Matt West as the new BART staff, Manager of Accessibility, in the Customer Access and Accessibility Department. Matthew West introduced himself.

Sabrina Baptiste, Office of Civil Rights (OCR), introduced herself.

Elena Van Loo mentioned travel reimbursement for the third quarter is due on October 10, 2023 and reminded members to update card numbers if they have changed.











- New faregates will have improved sounds. We will update BATF for input in the future during systemwide rollout.



GET TO KNOW

BART PD's Progressive Policing and Community Engagement Bureau

Dear BART rider,

Your safety is BART's top priority. The voices of riders like you are why the BART Police Department created the new Progressive Policing and Community Engagement Bureau. This initiative represents a bold approach to public safety that recognizes not every problem on BART requires a response by a police officer. The Bureau utilizes a mix of sworn and civilian BPD staff to bolster the department's visible presence in the system while offering more appropriate ways to respond to a range of calls for help.

"We're here for the community and we'll go on this journey with them."

Why a Progressive Policing Bureau?

BART Police Chief Ed Alvarez's vision for safety includes making BPD the most equitable law enforcement agency in the nation. Alvarez created the Bureau in 2020 to lead the way with new approaches to address systemic societal issues affecting public safety, including homelessness, mental illness, and addiction. Extensive community meetings were held with overwhelmingly positive responses to this approach from those who attended. Deputy Chief Ja'Son Scott, who has extensive experience in community outreach, leads the Bureau.

What makes the Bureau different?

BPD is among the first transit policing agencies in the country to create a Progressive Policing Bureau. Utilizing unarmed personnel such as Transit Ambassadors and Crisis Intervention Specialists boosts the visible safety presence on trains and in stations while ensuring BART is welcoming to all riders. By responding to hundreds of calls every month unarmed BPD staff also free up sworn officers for situations when a traditional police response is appropriate.

Transit Ambassadors and Crisis Intervention Specialists work with sworn officers in the Progressive Policing Bureau. They all wear special, dressed-down uniforms and work in Special Engagement Teams (SET) together throughout the BART system.

Transit Ambassadors

Provide presence and visibility on trains, platforms, and at stations. They're equipped with masks, Narcan (to respond to drug overdoses), and a police radio. They walk more than a dozen trains and stations on a typical shift.



Crisis Intervention Specialists

Have a background in social work and assess people experiencing mental health and other kinds of crises, including housing insecurities. Their focus is to connect people in crisis with support services.



If You See Something Say Something™

- Download the BART Watch app. Use it to discreetly report any concerning situation.
- Text BPD Dispatch at (510) 200-0992
- Call BPD by phone at (510) 464-7000
- Use the train intercom to speak with the train operator; use a white emergency phone in the station; or speak to any uniformed BART staff.



Tips for contacting BPD

- If you see someone in distress who might need medical attention or is experiencing a crisis, contact BPD dispatch to request a welfare check. If aboard a train, look for the car number at each end of the vehicle. If you're on a platform, look for signage to indicate the nearest entrance. Share as many specific details as possible with the police dispatcher. Members of the Progressive Policing Bureau are specially trained to respond to people in crisis.
- If you see a situation that could be dangerous, avoid engaging with anyone who is acting in a threatening manner. Try to move to a safe location to contact BPD. You can use the BART Watch app or text BPD to report something discreetly without making a phone call.
