# 4. Introduction to Chief of Police, Kevin Franklin and introduction to BART's Deputy Chief of Police, Ja'Son Scott

BART Chief of Police Kevin Franklin introduced himself as the newly appointed Chief of Police and thanked BATF members for their commitment to the committee and the invitation to come to this meeting. He mentioned getting feedback from BATF member is important. Chief of Police Kevin Franklin shared that BART is hiring BART officers in different departments within the BART Police Department.

BART Deputy Chief of Police, Ja'Son Scott, introduced himself and thanked BATF members for the invitation. He shared phone numbers for texting and calling non-emergency with the BART Police Department. Clarence Fischer would like to see BART Police Officers be more present on the BART trains.

Valerie Buell expressed her low confidence with the BART's Watch App. She mentioned she has used the app to report different incidences within the BART system and has been disappointed with the outcome.

Randall Glock asked whether to revisit BATF General Disability Awareness (GDA) pamphlet. BART Chief of Police Kevin Franklin and BART Deputy Chief of Police would like to see the latest pamphlet for review and discuss further at a later meeting.

# 5. BART's middle door marking update

Travis Huang presented on the item, "BART's middle door marker update."

He went over the scope of work for the middle door marking:

- ➤ We are procuring new decals to mark the middle car door for the new Fleet of the Future (FOF) trains on the platform
  - The decals with blue side design are for the middle doors, which designate the easiest access for patrons who use a mobility device (wheelchairs, powerchairs, etc.)
  - The decals with yellow side design are for doors at each end of the train, which will be installed system wide based on funding availability
- ➤ We are working on an expedited schedule to complete the installation by end of December 2023 or late January 2024 throughout the system
  - o Depending on labor resources, decal manufacturing and delivery time
- This work will be performed during blanket hours (non-revenue hours)
  - Weekdays about 3 to 4 hours work window
  - Weekends about 6 to 8 hours work window

Travis Huang mentioned the current middle door decal markings says, "3-Door Cars Only," will be replaced middle door decal markings with, "Middle Door."

The BART Accessibility Task Force is a public committee comprised of BART riders to advise the BART Board of Directors and staff on disability-related issues and advocate on behalf of people with disabilities and seniors to make the BART system accessible to all.

The BART Accessibility Task Force (BATF) generally meets on the fourth Thursday of each month from 2 p.m. to 4:30 p.m. The BATF meetings are open to the public and are located at the East Bay Paratransit Office, 1750 Broadway, 1st floor conference room, Oakland, CA 94612, which is adjacent to the 19th Street BART station street level elevator. Times and/or locations may vary for the November and December meetings.

# BATF member responsibilities include the following:

- 1. Provide input on issues and policies; capital projects; compliance with local, state and federal legislation; and other issues that might be brought to the BATF by the public, staff or the Board.
- 2. Develop recommendations which take into consideration the needs of people with different disabilities and seniors.
- 3. Participate in the development of proposed new policies and the planning and implementation of new services that affect people with disabilities and seniors who use BART.

- 5. Act as a resource group to BART staff who interact with people with disabilities and seniors to answer complaints, develop new programs, solve architectural problems in the system, conduct staff disability training, and address other areas as needed.
