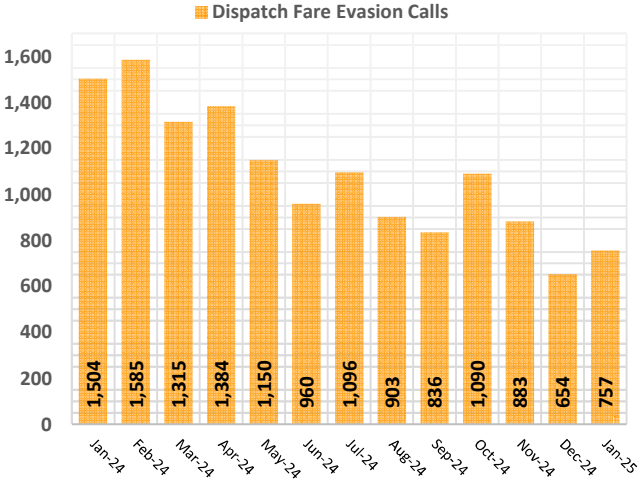

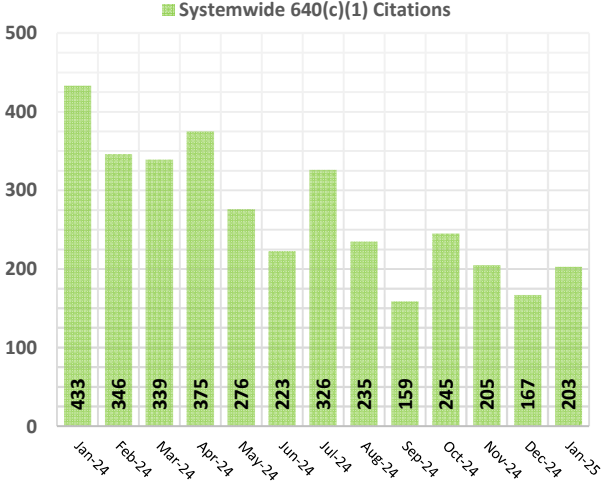
PRIORITY TYPE 1 - 3 CALLS



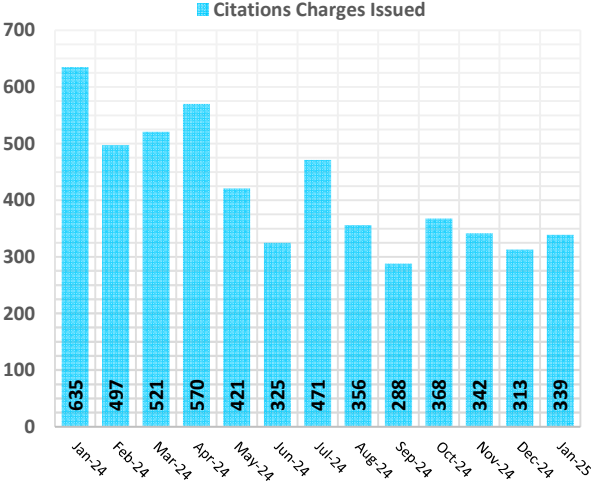

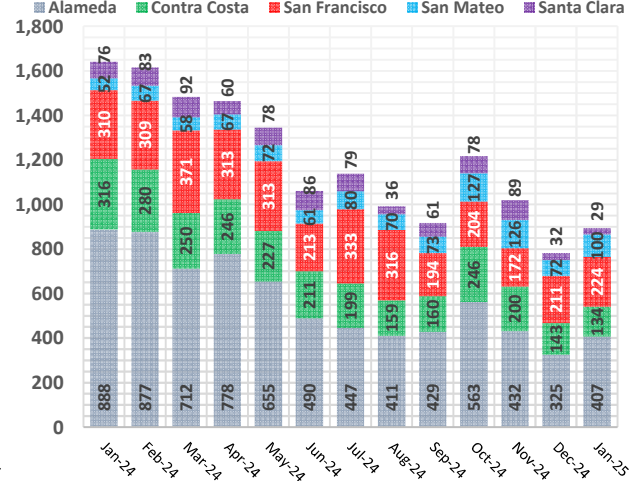

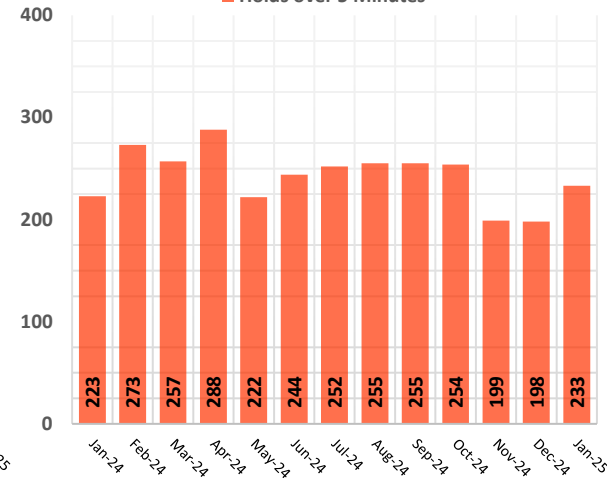

Emergency Response (Minutes)



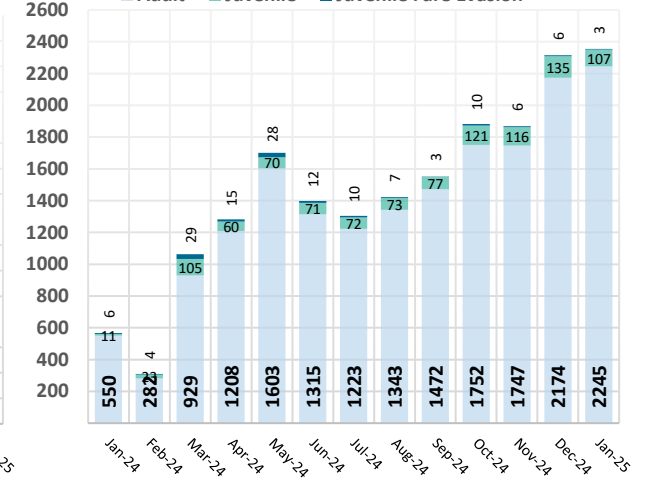

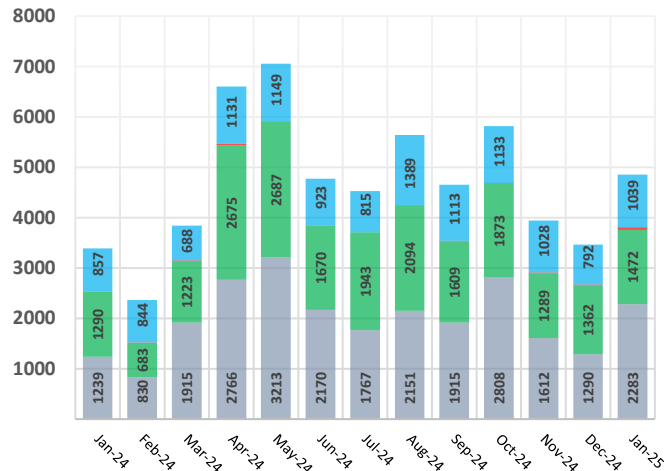

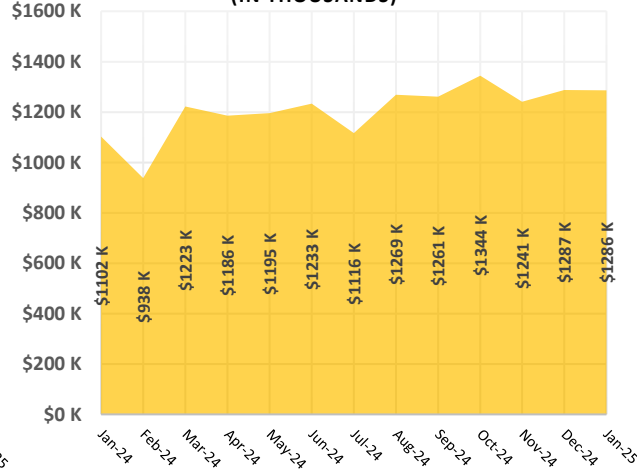

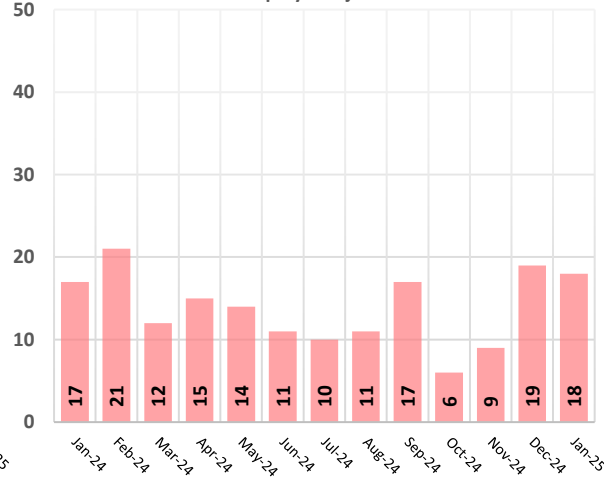
## OVERTIME UTILIZATION

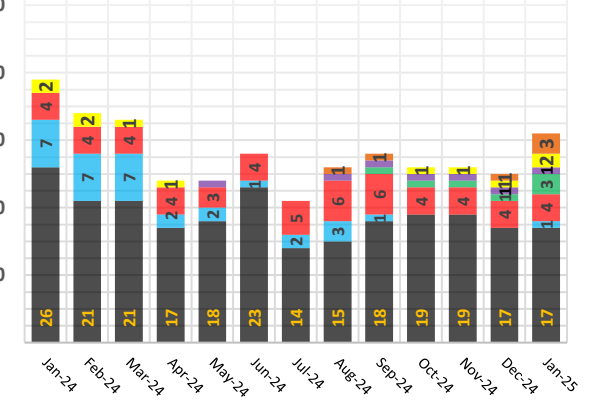

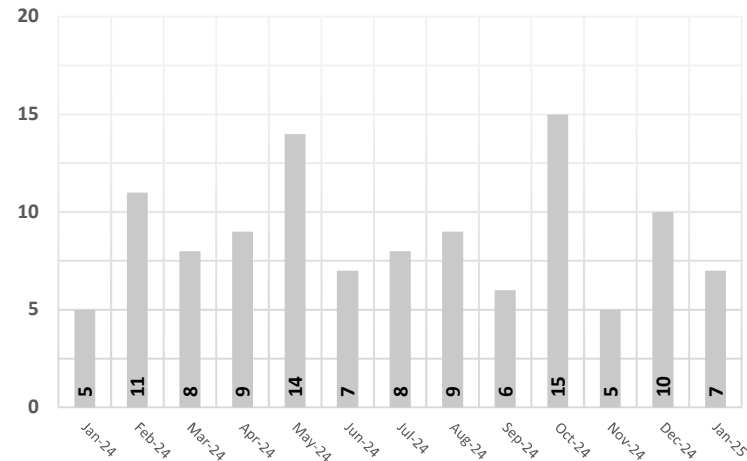

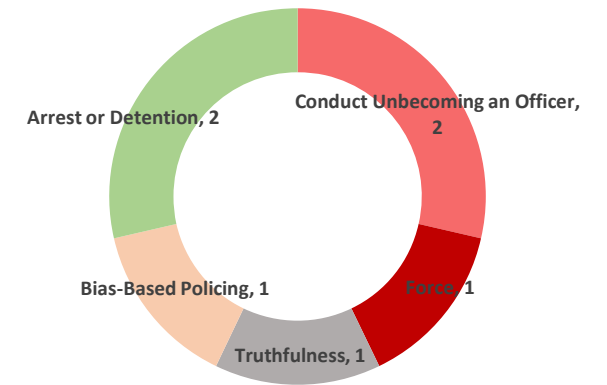

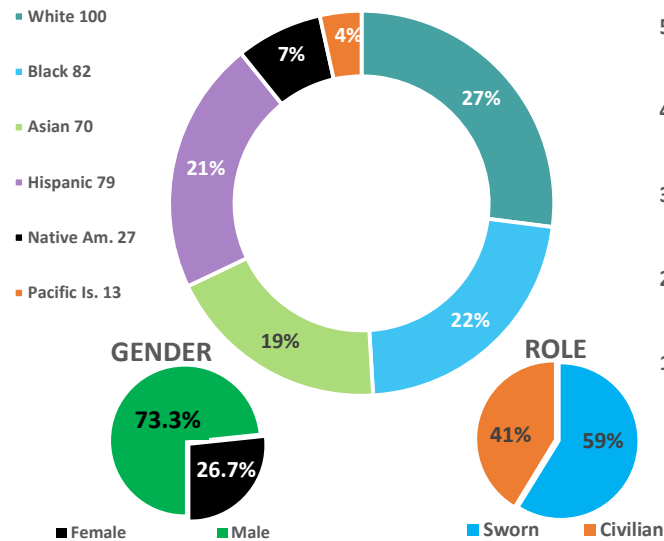


### IA COMPLAINTS RECEIVED<sup>1</sup>

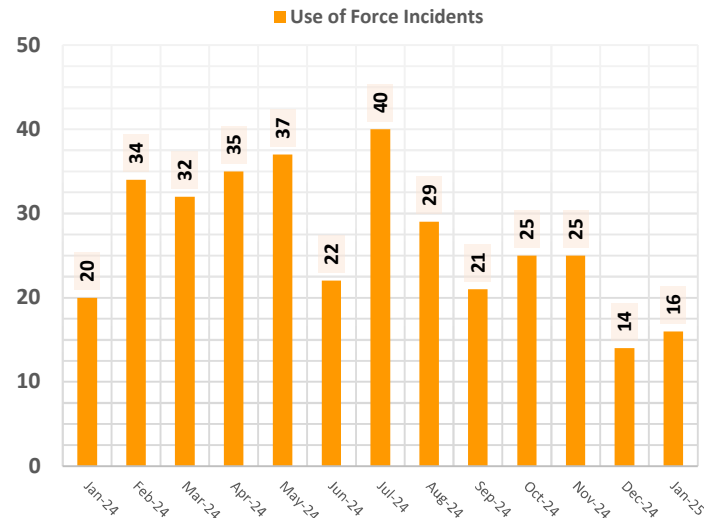

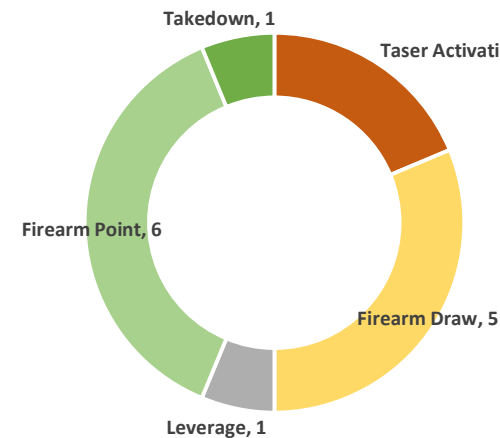
### DEPARTMENT ETHNIC DIVERSITY



### USE OF FORCE INCIDENTS

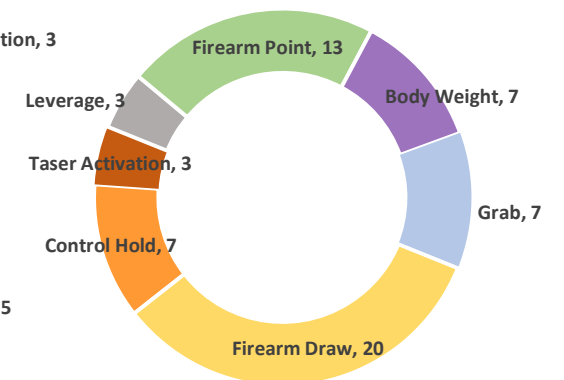


### INCIDENT FORCE OPTIONS USED<sup>2</sup>
