




CONTRACT TITLE: ACCESSIBILITY IMPROVEMENTS AT VARIOUS BART STATIONS

A printed copy of proposed Addendum No. 2 is attached. This addendum will officially extend the date for receipt of bids from the current date of October 6, 2015 to an amended date of January 19, 2016. This time extension is required in order that the District can follow up this Addendum with a third Addendum No. 3 which will provide for changes in the original Invitation to Bid contractual specifications as they pertain to better defining a handicap ramp and slopes in accordance with ADA requirements at the Lafayette and West Oakland Stations. The uncertainty of the specifications was noted by numerous potential bidders during the Job- Site Walk on the Pre- Bid Meeting. Additionally the Addendum No. 3 will include a revision to the BART Insurance requirements pertaining to this Contract. The new BART Program Manager for this effort, Carl Orman, takes over from Sai Ramadas, who has gone on terminal leave. BART has engaged the services of one of its On-Call Engineering consultants to revise the contractual specifications which are currently being drawn up to be released in the near future.

Proposed addendum is approved as to form.






