### Nighttime work at Coliseum Station

#### CONSTRUCTION DETAILS

##### Summary of Activity

Nighttime construction work at Coliseum Station will include light truck and forklift movements along with some heavy drilling inside the station for utility work and seismic retrofit activity.

##### Estimated Start/End Time

Thursday night, April 4 at approximately 9:00 pm to 4:00 am nightly through Saturday morning, April 12.

##### Estimated Duration

Approximately 7 hours at night into early morning.

##### Impacts

- Some periodic noise and additional lighting related to forklift moves and drilling inside the Coliseum Station off San Leandro Street.

Dear Coliseum Station Community,

Nighttime work inside Coliseum Station to accommodate utility and seismic construction is expected to start Thursday evening, April 4 at approximately 9:00 pm nightly, working through BART's blanket, non-service hours, continuing through Saturday morning, April 12. Sound barrier blankets are being installed and use of quieter drilling tools will be used to assist with noise levels. Noise, dust, and odors will be monitored, and local regulations will be enforced to minimize any inconveniences. This activity is related to the BART systemwide Earthquake Safety Program, seismic retrofit construction occurring at multiple locations inside and outside the Coliseum Station. Despite the rains, construction continues at a robust pace and **Coliseum Station REMAINS OPEN for BART riders during construction.** Similar construction is also occurring at Fruitvale Station, which is nearing completion.

We apologize for the inconvenience and appreciate your patience and cooperation during this work. As always, safety is BART's top priority. Our aim is to complete seismic retrofit work as quickly as possible, while maintaining BART service.

### Work Locations at Coliseum Station

<p>Under BART alignment, outside the Coliseum Station, just south of the building, off San Leandro Street, construction continues and is <b>NEARING COMPLETION</b> – expected Spring 2019.</p>	<p>Under BART alignment, outside the Coliseum Station, north of the Station building is under construction in the ADA and BART parking lot located off San Leandro Street. ADA parking has been temporarily relocated north of its permanent location under the BART alignment off San Leandro Street. <b>Please allow additional time for travel to/from and through Coliseum BART Station following all directional signage.</b></p>	<p>Inside BART Coliseum Station on the south-end of the Concourse under the BART alignment. Stage 2 has temporarily closed the southwest stairwell between the Concourse and Platform inside the patron area. This work is expected to proceed for approximately 3 months. All escalators, stairs (except southwest stairwell), elevators, add-fare and parking machines are accessible with detours. Stage 3 inside the Station has begun overhead with occasional nighttime work, with daytime work <b>CONTINUING.</b></p>	<p>Located on the west side of San Leandro Street under the Coliseum Pedestrian Bridge, seismic retrofit work is expected to begin in April. Currently, there is <b>NO CONSTRUCTION activity at this location impacting pedestrian access.</b></p>

Note: During Construction, Coliseum BART Station is expected to remain open and accessible with some detours and directional signage. We apologize for the inconvenience. Thank you for your patience.
