**6M3421 Traffic Control Services for BART's C55
and R65 Interlocking Projects**

The SAN FRANCISCO BAY AREA RAPID TRANSIT DISTRICT ("BART" or District"), 300 Lakeside Drive, Oakland, California, is advertising for proposals for Traffic Control Services for BART's C55 and R65 Interlocking Projects, Request for Proposals (RFP) No. 6M3421, on or about November 1, 2018, with proposals due by **2:00 PM local time, Tuesday, December 11, 2018**. SCOPE OF SERVICES

The San Francisco Bay Area Rapid Transit District (hereinafter referred to as "BART" or "District"), a California Rapid Transit District, intends to engage the services of a traffic control firm ("CONTRACTOR") to provide services hereinafter described for its C55 and R65 Interlocking Projects ("Project"). The District presently intends to enter into a three-year Agreement, with two one-year options to extend the term, with the CONTRACTOR selected.

The services sought at this time are for those of a firm that routinely provides traffic control services. In brief, the services consist of the following:

- A. Perform all work to obtain all required permits from all authorities having jurisdiction in order to perform traffic control services and procure all required permits from all authorities having jurisdiction in order to perform traffic control services.
- B. Perform traffic closure, flagging services and detour services.
- C. Prepare and develop traffic control plans as specified and required by BART and authorities having jurisdiction of the work and service area(s).

REQUIRED REGISTRATION ON BART PROCUREMENT PORTAL

In order for prospective Proposers to be eligible for award of an Agreement being solicited on the BART Procurement Portal, such Proposers are required to be currently registered to do business with BART on the BART Procurement Portal on-line at <https://suppliers.bart.gov> and have obtained Solicitation Documents, updates, and any Addenda issued on-line so as to be added to the On-Line Planholders List for this solicitation.


If a prospective Proposer is a joint venture or partnership, such entity may register on the BART Procurement Portal with the entity's tax identification number (TIN) and download the Solicitation Documents so as to be listed as an on-line planholder under the entity's name prior to submitting its Proposal. If such entity has not registered on BART Procurement Portal in the name of the joint venture or partnership prior to submitting its Proposal, provided that at least one of the joint venturers or partners registered on line on the BART Procurement Portal and downloaded the Solicitation Documents so as to be added to the On-Line Planholders List for this solicitation, such entity will be required to register with the entity's TIN as an on-line planholder following the submittal of Proposals, in order for the entity to be eligible for award of this Agreement.

PROPOSERS WHO HAVE NOT REGISTERED ON THE BART PROCUREMENT PORTAL PRIOR TO SUBMITTING A PROPOSAL, (OR FOR A JOINT VENTURE OR PARTNERSHIP AS DESCRIBED ABOVE PRIOR TO AWARD) AND DID NOT DOWNLOAD THE SOLICITATION DOCUMENTS FOR THIS SOLICITATION ON-LINE SO AS TO BE LISTED AS AN ON-LINE PLANHOLDER FOR THIS SOLICITATION, WILL NOT BE ELIGIBLE FOR AWARD OF THIS AGREEMENT.
