



	QUESTION/CLARIFICATION REQUESTS	DISTRICT'S RESPONSE
1.	Are axles to be included with the step chains? No mention of axles or axle widths is made in the engineering spec. Just want to be sure.	Correct, the IFB is for Fujitec chain only. When you replace Fujitec chain, it was designed to reuse the axles and rollers and replace only those items that have worn out.
2.	Are outboard polyurethane rollers to be included with the chains? Only the protection rollers on the bushings are mentioned in the engineering spec.	Outboard polyurethane rollers are not included with the chains. The mentioned protection rollers over the bushings are steel, and are an integral part of step chain
