# Bay Area Rapid Transit (BART) Citizen Voting Age Population (CVAP) for Proposed Board of Director Districts

# Citizen Voting Age Population (CVAP) by District (Plan A, Plan B, Plan C)

The following report contains data tables showing changes in Citizen Voting Age Population (CVAP) between BART Board of Director districts for Plan A, B, and C. Changes in Citizen Voting Age Population (CVAP) generally correlate with shifts in total population for each district and adjustments made for population balance using 2020 US Census Block geography. Total population is the primary consideration when balancing districts and calculating population variance. However, CVAP becomes an important factor if there is an opportunity to create a Voting Rights Act (VRA) district. The creation of a VRA district is recommended when the following two criteria are met for a proposed district.

- 50% +1 (simple majority) of a protected ethnic class or language group AND
- 50% +1 (simple majority) of Citizen Voting Age Population (CVAP)

#### **Notes and Data Sources**

- 1. Citizen Voting Age Population (CVAP) based on data from the <u>American Community Survey</u>.
- 2. Total population, demographics, and district geography are based on 2020 U.S. Census Blocks.
- 3. Population figures account for Readjusted California Prisoner Population (PL 94-171) from the <u>California Statewide Database</u>.
