## EARTHQUAKE SAFETY PROGRAM STAGE 4 CONSTRUCTION CREATES TEMPORARY DETOURS INSIDE COLISEUM STATION

## **Dear Customer:**


As part of the BART systemwide Earthquake Safety Program, work crews continue working inside and outside the COLISEUM Station for seismic retrofit construction. Starting approximately April 22, Stage 4 construction will begin, expanding the work area northward inside the Concourse, located closest to the northwest entrance near the elevator/stairs/escalators to the Pedestrian Bridge. Add fare and parking machines, restrooms, elevators, escalators, and stairs – except the southwest stairwell, will remain open during construction. Please watch for directional/safety/informational signs, allow additional travel time through the Concourse and between the Concourse and Platform; and proceed around construction areas with caution. Similar earthquake safety retrofit construction is underway at Fruitvale Station, and is in its final phases.

You will see construction equipment accessing the site such as scissor lifts, drill rigs, concrete pump/hose and trucks, and temporary scaffolding/structures. Earthquake Safety construction consists of seismic retrofit work performed on each footing and pier cap (a beam connecting two columns) that serves to support the BART trackway under the alignment.

**Stage 1 Closure: Escalator open.** Construction continues w/partial enclosures on the sides and behind the escalator located on the south-end of the Concourse, allowing for patron use to and from the Platform during construction.

Stage 2 Closure: Construction requires temporary closure of the southwest stairwell for approximately 3 months. Stage 3 Closure: Pedestrian pathways narrowed with detours. Construction in the area located north of the fare gates and west of the pedestrian tunnel continues with a temporary enclosure overhead and pedestrian tunnel for access into/from the Station.

Stage 4 Closure: Starting approximately the week of April 22, construction will expand further north inside the station with additional pedestrian pathways narrowed with detours. This construction will create a second temporary pedestrian tunnel, approximately 8-feet wide, for safe movement around construction, and an overhead enclosure structure. All construction work areas will be enclosed with temporary structures overhead and on the ground, with fenced-in plywood barriers/temporary soft delineators. \*All dates are approximate and subject to change



**Pardon the noise** -- this construction includes heavy drilling that will make noise. Sound barrier blankets are in place to minimize noise levels. Noise, dust and odors will be monitored, and local regulations will be enforced.

## **Stage 4 Construction Activity inside Coliseum Station**

Seismic retrofit construction continues outside Coliseum Station on both the north and south-end of the Station, mainly off San Leandro Street. Temporary relocation of ADA and BART parking located on the westside (San Leandro Street side) of the station continues. Construction outside the station on the south-end is nearing completion.

We recognize the inconvenience and appreciate your patience and cooperation during this work. As always, safety is BART's top priority. Please proceed around construction areas with caution and watch for signs with safety information and other notices. Please be advised that changes/modifications may be required at any time; the construction team will make every effort to minimize inconveniences. Our aim is to complete seismic retrofit work as quickly as possible, while maintaining BART service.
