As of 3/18/21, San Mateo County has moved to the Orange tier with all other Bay Area Counties remaining in the Red tier. San Francisco is expecting to move to the Orange tier on 3/24:

RE: Revised State Guidance on Public Transit Worker Vaccine Eligibility

Dear Governor Newsom,

On behalf of the undersigned Bay Area public transportation operators, we would like to thank you for including public transit workers within the state's revised COVID-19 vaccine distribution guidance. We applaud this decision to prioritize public transit workers for the vaccine and are heartened by the Administration's recognition of the critical role our employees play in maintaining safe and reliable transit operations.

Since the onset of the pandemic, Bay Area transit systems established health standards and have helped essential workers and transit-dependent riders reach their destinations. Now, we are working hard to ensure vaccine distribution locations are accessible by offering free rides and establishing shuttles to sites for people without a car or those who need mobility assistance. Larger transit systems with parking lots and plazas have also partnered with county officials, health care providers, and community groups to host vaccination sites and free COVID-19 testing. We believe transit-friendly vaccine and testing sites will help provide equitable community access, especially for vulnerable Bay Area populations that have been disproportionately impacted by the pandemic.

Our ability to continue to run reliable service and support the region's re-opening will depend on keeping a healthy transit workforce. An outbreak within a transit facility or the need to quarantine many employees due to exposure could bring buses and trains to a halt. Hence, vaccinating public transit workers, especially those at high risk for occupational exposure, will help ensure adequate transit service to aid in the Bay Area's recovery efforts.

Thank you again for reprioritizing public transit workers within the state's vaccine distribution guidance. Our employees have bravely faced this pandemic for nearly a year, and we appreciate the state's renewed commitment to protecting their health by availing priority to this life-saving vaccine.

Important Update: Public Transit Workers Now Eligible for Vaccine!

On 3/11/21 the California Department of Public Health updated its vaccination guidance providing priority vaccine access to California's public transit workers, effective March 15, 2021.

All BART employees can schedule a vaccination appointment using the following methods:

1. Schedule with My Turn by visiting the myturn.ca.gov site, or by calling (833) 422-4255.
2. Schedule with a local provider: Some [local health jurisdictions](#) provide vaccination appointments separately from My Turn. The CDC VaccineFinder tool at <https://vaccinefinder.org/> can be used to find vaccination locations near you.

Face Mask Reminder: Per the CDC and California Department of Public Health, it is important to continue to wear a mask even after receiving the COVID-19 vaccine to protect yourself and others. After you've been fully vaccinated against COVID-19, you should keep taking precautions in public places like wearing a mask, staying 6 feet apart from others, and avoiding crowds and poorly ventilated spaces until we know more.

Frequently Asked Questions:

Q: Will I be required to receive a COVID-19 vaccine?

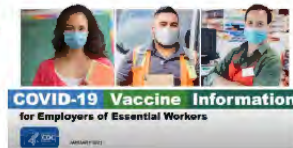
A: No

Q: How many COVID-19 vaccine doses are needed?

- Two doses for the Pfizer/BioNTech vaccine, 21 days apart
- Two doses for the Moderna vaccine, 28 days apart
- One dose for the Johnson & Johnson's Janssen vaccine

Q: How much will the COVID-19 vaccine cost?

A: Nothing. COVID-19 vaccines, including their administration, are free.

 - Deep Cleaning of Facilities With Positive COVID-19 Cases – Stations, Oakland Shops, BPD Offices & Vehicles and Administration Building

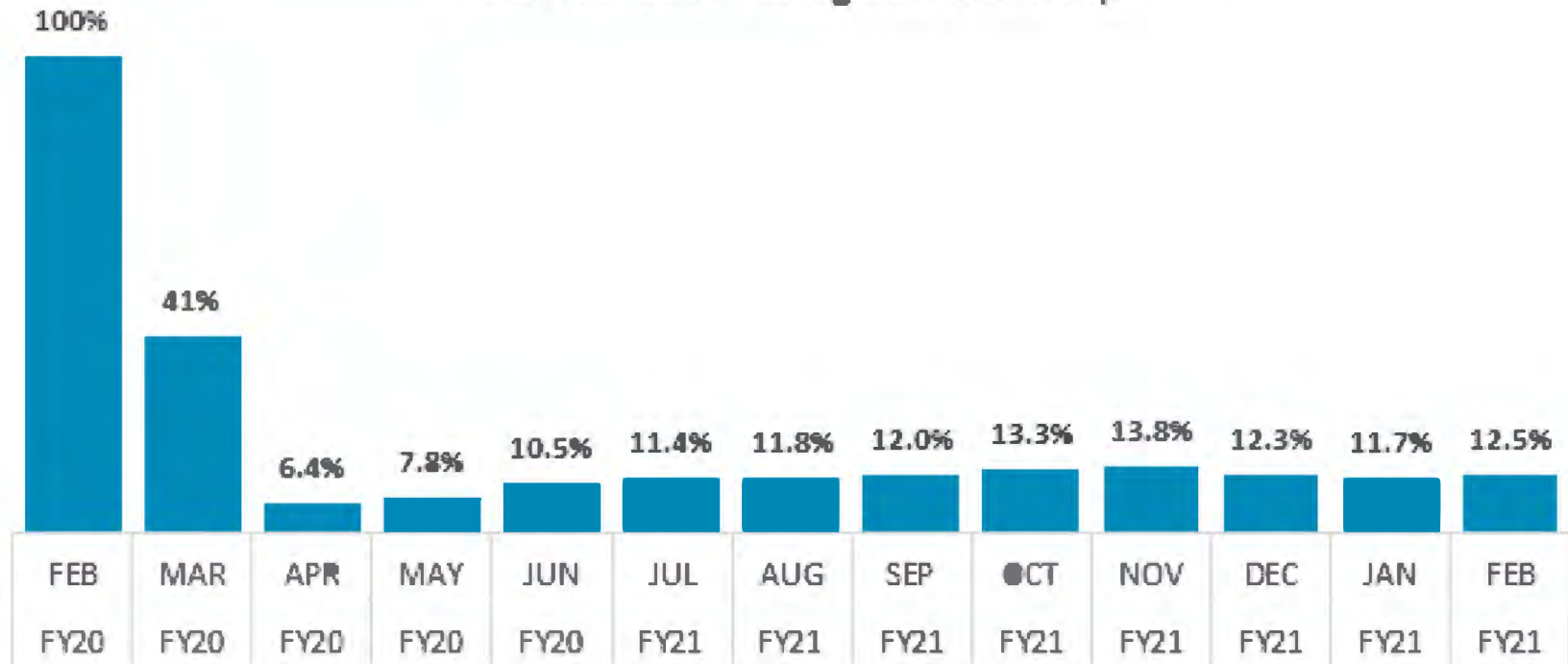

March Service Goals

Continue with a train schedule designed for flexibility

- 30-minute base headway
- Up to 44 commute trips at 15-minute (Yellow, Red, and Green Lines)
 - 18 running now
 - Ability to add 26 with ridership growth



Redesign how trips between Millbrae and SFO operate

- All trains arriving and departing Millbrae on Platform 3 for Caltrain transfer
- Weekdays all Red Line trains will continue beyond Millbrae to SFO
- Off peak and weekends, Yellow Line will continue beyond SFO to Millbrae
- No more “Airport Shuttles” weekdays

BART Police COVID-19 Deployment

- Emergency patrol staff deployed with 3/12 and 4/12 schedule (began in May 2020)
- Adjusted patrol schedules to maximize presence during revenue hours
- Fixed post at select stations at opening and during the day
- Increased presence of Community Service Officers (CSO), Critical Asset Patrol (CAP) Team, K9 Officers, Fare Inspector Officers (FIO) and Transit Ambassadors in the BART Core
- Giveaway Mask Program available to unmasked persons in the BART system

Mask Mandate

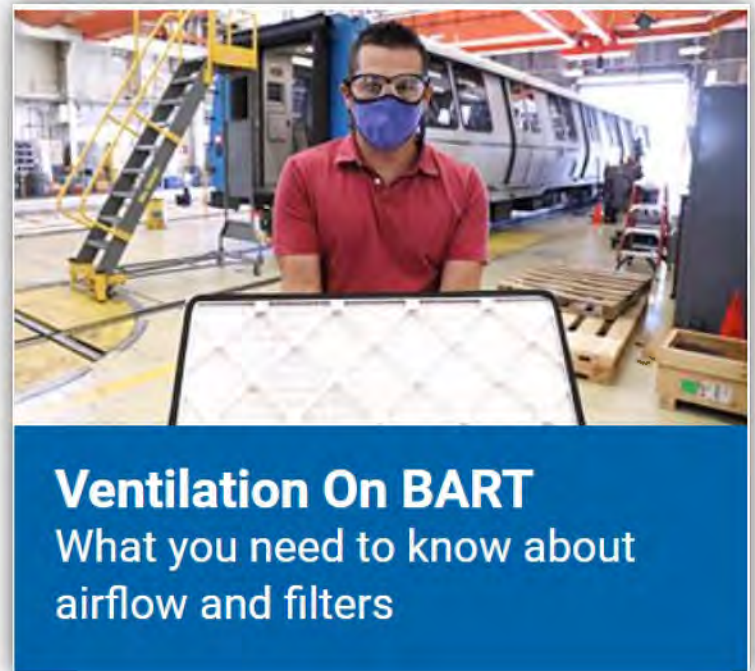
- New posters showing how to properly wear a mask
- New audio announcements, and platform digital messaging, making clear even if you are vaccinated, you must wear a mask to protect others
- Historical mask compliance data prominently featured at www.bart.gov/COVID

Transparent Communication

- Daily ridership posted at bart.gov/COVID
- Weekly train car loading charts posted at bart.gov/crowding and social media
- Airflow and air filter information featured on bart.gov homepage
- Worked with CalOES and FEMA to improve information about getting to Coliseum Pedestrian Vaccination Site
- 985 personal hand straps sold to date; 1000 put aside for giveaway events



Blue Ribbon Taskforce Transit Coordination

- Transit Marketing and Communications staff meet weekly
- Consolidated transit-friendly vaccine destinations posted at [HealthyTransitPlan.com](https://www.healthytansitplan.com)
- MTC is leading research effort on transit ridership/behavior and employer surveys; public poll out in the field in April
- MTC held focus groups to guide Return-to-Transit campaign to be ready by late spring/early summer



Coronavirus Response & Relief Supplemental Appropriations Act of 2021 (CRRSAA)

- MTC allocated \$103.7M in true-up funds in January
- MTC Programming & Allocations Committee recommended that BART receive an additional \$274M from second tranche of funding. Full Commission approval expected 3/24.
- Tranche 1 funds have been awarded to BART by FTA. Staff will submit application for Tranche 2 funds upon approval by MTC commission.
- BART will continue to draw down funds from FTA using the same process as CARES Act funds

American Rescue Plan Act of 2021

Formula funds for operating expense: Estimated \$1.7 billion for Bay Area transit

- Awaiting FTA apportionments for urbanized areas to be released
- MTC and operators will likely develop an allocation process and formula jointly (like CARES Act and CRRSAA)
- At least some funds anticipated to be allocated in the next 2-3 months

Capital funds: Estimated \$75-85M for BART's Transbay Corridor Core Capacity Project through additional CIG Program funding

- Outreach to FTA for guidance on additional funds, request maximum flexibility in expenditure of monies for project-related activities

Additional operating assistance: Available through application to the Secretary of Transportation

- \$2.2 billion available to agencies with demonstrated financial need
- Program guidelines have not yet been released – staff will monitor
