Options: The District reserves, in its sole discretion, the unilateral right to exercise any or all Options identified in the Contract, in any order, at least thirty (30) Calendar Days prior to the completion of the Base Bid Work or any exercised Option. If the Option(s) are exercised by the District, the provisions of General Conditions Article P4.4 and Supplementary Conditions Article SC4.2 shall apply for directing the Contractor to proceed with any Option(s) and incorporating the Contractor's price for the completion of such Option(s) into the Contract Price. Identification of the Options in the Contract Documents does not commit the District to exercise any Options.


