

OFFICIAL RULES: BART BLUE SKY FESTIVAL SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

Entry: To enter, visit <http://bartable.bart.gov/contests> and follow the prompt to enter the sweepstakes. To enter: Post of a photo of yourself dumping the pump; Share it on Twitter or Instagram with the hashtag #BARTable (make sure your post is public); You can also send your selfie by emailing your submission to bartable@bart.gov; mailing it to: Dump the Pump, Attn: BART Marketing, 300 Lakeside Dr., Oakland, CA 94612. We must receive all entries by 12:00 am PST on Thursday, June 25, 2015. Public libraries have free internet access. Each participant will need to provide the following information: first and last name, phone number and email address. By entering the sweepstakes registration during the promotion period, each participant will earn one (1) sweepstakes entry. Limit of one (1) entry per participant during the promotion period.

1. Sponsor is San Francisco Bay Area Rapid Transit District (BART), P.O. Box 12688 (LKS-18) Oakland Ca 94604-2688.

2. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are 18 years of age or older at the time of entry. Employees and agents of Sponsor and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes. 3. Drawing: Around June 26, 2015, sponsor will conduct a random drawing for one (1) City CarShare membership; one (1) \$100 Clipper card; and one (1) \$20 BikeLink card. Potential winner will be notified by email by June 29, 2015. If potential winner does not respond within three (3) business days, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate winner will be selected via random drawing. Providing all eligibility requirements are met, potential winner must claim prize at Sponsor's headquarters in Oakland, CA, or another location specified by Sponsor.

4. Except where prohibited by law, potential winner may be required to complete, sign and return an Affidavit of Eligibility/Ownership/Liability Release and Publicity Release (the "Affidavit") prior to claiming prize. Affidavit must be returned within fourteen (14) calendar days or prize may be forfeited and an alternate winner will be selected.
