**Project Title** 

Microtransit first/last mile services to Walnut Creek BART

Describe the project in 250 words or less. Include goals, risk and uncertainties, and readiness of the project. This grant application uses an innovative pay-for-performance model to maximize the air quality benefits of microtransit first/last mile services to BART. BART has found that, left to chance, most TNC first/last mile trips to BART hurt air quality because they substitute for bus, walk, and bicycle. Attachment A is from a spring 2018 survey of 536 random TNC trips to and from BART. Only 19% of the TNC trips to/from BART (see green circles) tend to improve air quality (16% from those who take a TNC instead of driving to BART, and 3% from those who wouldn't have taken BART without the TNC first/last mile connection). The 16% who took a TNC instead of parking at BART free up a parking space to accommodate another BART rider who would probably have driven all the way to work if they couldn't get parking. Our approach with this grant is to focus the grant funds on just these two groups to maximize air quality benefits, and to ensure we don't expend funds to convert walkers, bikers, or bus riders to microtransit for the first/last mile portion of the trip. This program is proposed for the Walnut Creek station, with possible expansion to the Pleasant Hill and Concord stations if budget permits. The purpose of starting with a single station first is to maximize service density/efficiency, and increase the chances that the program can be sustainable in the long run. Stations are subject to change based on mutual agreement with BAAQMD.
