Such Small Businesses will be granted reduction in their Bid Prices, for evaluation purposes only, of 5% of the Bid Price of the lowest responsible Bidder, up to a maximum of \$250,000. Following such a reduction, all Bids will be compared and Award will be made to the responsible Bidder with the lowest evaluated price. The Contract Award will be for the amount of the original Bid.




