<u>Project Stabilization Agreement – Local Hire Requirements</u>

The Local Hire Program (LHP) - Article 9 of the Project Stabilization Agreement (PSA), has established goals for the hiring and retention of Local Area Residents. (9.1)

- 50% Local Area Residents: all hours worked on the Project, on a craft by craft basis, will be worked by Local Area Residents (9.2.1)
- 25% Project Local Impact Area: will be worked by residents of the Project Local Impact Area (Oakland), (9.2.1)
- 20% Apprentices: will be worked by apprentices (Local Area Residents only), (9.2.2)
- 50% of all Apprentice Hours: of all apprentice hours will be worked by residents of Oakland (9.3)

Labor Results Summary

Attachment A is the labor report which includes payroll data available in the Elation System through January 31, 2014, by contractor and by trade. The results are summarized in Table-1 below:

The results show that the Flatiron/Parsons JV (JV) continues to exceed the 50% goal for Local Area Residents (four BART counties) with 70.66% participation. The utilization of Project Local Impact Area (Oakland) residents is on track as well.

Overall Apprentice participation improved and the JV is just shy of the 20% goal with 18.9% participation. Additionally, per the local hire program (Article 9) of the Project Stabilization Agreement, only Local Area Residents shall be utilized as apprentices on the project. Currently Local Area Residents make up 90% of the apprentices on the project. The JV continues to meet with our subcontractors and stress the need to increase apprentice utilization. We are exceeding the Oakland-Apprentice goal of 50% with 60.9% participation and overall are seeing a positive general trend in all categories toward reaching the project goals.

There are 36 subcontractors actively working on the project this month. 16,819.50 hours were worked in the month of January, and a total of 614,058.60 hours have been worked through January 21, 2014; 204,772.65 by JV and 409,285.95 by subcontractors.

Apparent Non-Compliance - Corrective Action

FPJV met with Bleyco Construction in December to discuss their lack of apprentice utilization. Bleyco noted that they were not aware of the apprentice requirement but committed to engage two Oakland resident apprentices on 12/16 and employ two additional apprentices at the start of the New Year. Bleyco will have a 16 person crew for the next few months. To date they have brought on two Oakland apprentices, whom are working full-time. We have asked them to assess the possibility of engaging at least one more.

• FPJV has instructed Turner to ensure that their contractors stay current with their certified payroll as several of their contractors have fallen behind and it is therefore hard to assess their compliance with the local hiring goals.

The JV continues to encourage subcontractors to utilize graduates from Cypress Mandela Training Center – as a resource for Oakland apprentices. Additionally the JAC recently awarded a contract to Cypress Mandela to work with the apprentices that have graduated from local pre-apprenticeship programs and have worked on the OAC project. We have identified 133 local area apprentices that have worked on the project and to date 20 of those individuals have expressed interest in working with Cypress.

<u>DBE Carve-Out</u> - No waivers have been requested from DBEs participating on the program.
