The price entered by the Bidder in the "ITEM TOTAL" COLUMN FOR Bid Item No. 2 is the amount that the bidder will reimburse the District for providing BART safety monitors in accordance with Contract Specification Section No. 01 11 00 (Summary of Work); Article No. 1.11, entitled "District Support". If the successful Bidder finds that the actual BART support amount required to complete the project exceeds the estimated amount found in the Bid Schedule, the Contractor shall reimburse the District for the full actual amount, including the amount in excess of the estimated amount. If the successful Bidder finds that the actual BART Support amount required to complete the project is less than the estimated amount, the Contractor shall only reimburse the District for the actual BART Support amount.

The above item totals for all Bid Items 1 through 28 are submitted by the Bidder for the convenience of the District. In the event of a discrepancy between the Bid unit price and the amount entered in the item total column, the Bid unit price shall govern. The District will calculate the total Bid Price based on the unit prices or lump sum prices bid, as applicable. In the event of a discrepancy between the District's calculations and the item totals for all Bid Items as submitted by the Bidder, the District's calculations shall govern.

The District reserves the right, in its sole discretion, to make no Award, or to make an Award to the lowest responsible Bidder as determined by adjusting the Bid Price for Bidders that are eligible for the Small Business Program preference as described in the Instructions to Bidders Paragraph 14.B.1.

FOR A BID TO BE CONSIDERED, ALL ITEMS MUST BE BID.

THE DISTRICT RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS.

If this Bid shall be accepted and the undersigned shall fail to contract as aforesaid and to give the two bonds in the sums to be determined as specified, with surety satisfactory to the District, or to provide specified Certificates of Insurance within ten (10) Days after the Bidder has received notice from the District that the Contract has been

awarded, unless the District, in its discretion, allows additional time in writing for such submissions, the District may, at its option, determine that the Bidder has abandoned the Contract; thereupon this Bid and the acceptance thereof shall be null and void, and the forfeiture of such security accompanying this Bid shall occur and the same shall be the property of the District.

Accompanying this Bid is (1) BID BOND in an amount equal to at least ten percent (10%) of the total Bid Price.




