SUBJECT: BART Board 2018 Workshop

The annual BART Board Workshop will be held on February 8-9, 2018, at the Renaissance Club Sport, Pleasant Hill, This location is a ten-minute walk from the Pleasant Hill BART Station. This event offers an opportunity for more extensive conversation among Board members, and between the Board and staff on the most important topics for the new year.

I wanted to take this opportunity to summarize some of the key topics planned for this year's agenda. This year's strategic conversations focus on our financial outlook, our passengers' current quality of life and our efforts to improve the public's experience on BART. The agenda also includes a report on the state of the region; the implications of pension funding strategies; an update on non-passenger revenue opportunities; an extended discussion of efforts related to homelessness, public safety, station cleanliness, fare evasion and service reliability: an update on Measure RR activities; and a discussion of upcoming major projects.

In the past, we have discussed special topics such as the Customer Satisfaction Survey. sustainability, art and parking policy. These topics will not be covered during this year's Board Workshop; staff plan to bring these topics to the Board for discussion throughout the calendar year. As you will recall, parking management, policy and enforcement were discussed at the January 25th Board meeting.
