

#### MANAGER OF RAIL OPERATIONS

### DEFINITION

Under general direction, directs, manages, supervises and coordinates the District's rail activities and operations within the Transportation Department including developing and implementing methods and procedures for efficient and effective train operations; administers the Transportation department's safety program; coordinates assigned activities with other divisions, departments and outside agencies; assists the Assistant Chief Transportation Officer, Service Delivery in overseeing and managing objectives, standards, and performance levels of Supervisors, Foreworkers, and Train Operators; and performs related duties as assigned.

### **CLASS CHARACTERISTICS**

This is a full-scope managerial classification which directs and coordinates, through supervisory staff, activities relating to the development, preparation and dissemination of procedures, standards, directive, and manuals for rail operations, safety, passenger service, and performance reporting, and managing capital improvement projects for rail operations. The classification is accountable for accomplishing departmental goals and objectives and for furthering District goals and objectives within general policy guidelines. This classification is distinguished from the Assistant Chief Transportation Officer, Service Delivery in that the latter has overall responsibility for managing all activities relating to rail operations. This classification manages through subordinate supervisory staff, the multi-shift operations and staffing of yard and revenue train service activities.

### **REPORTS TO**

Assistant Chief Transportation Officer, Service Delivery or his/her designee.

**EXAMPLES OF DUTIES** - Duties may include, but are not limited to, the following:

- Assumes management responsibility for assigned services and activities of the rail operations for the Transportation Department including development of operational strategies for construction and maintenance activities, coordinating safe and efficient revenue operations, and developing and administering assigned safety programs.
- 2. Manages and participates in the development and implementation of goals, objectives, policies and priorities for assigned programs; recommends and administers policies and procedures.

- 3. Monitors and evaluates the efficiency and effectiveness of service delivery methods and procedures; recommends, within departmental policy, appropriate service and staffing levels; oversees and monitors the provision of quality customer service at designated location.
- 4. Plans, directs, coordinates and reviews the work plan for assigned staff; assigns work activities, projects and programs; reviews and evaluates work products, methods and procedures; meets with staff to identify and resolve problems; oversees, manages and coordinates department decisions with the Assistant Chief Transportation Officer, Service Delivery and Labor Relations on matters of employment, employment relations, disciplinary action to ensure continued labor management dialogue, working relations, and direction of shared interest concerns.
- 5. Develops, prepares, implements and evaluates operational strategies with other departments to facilitate maintenance and construction project activities; ensures that adverse impact on revenue service due to maintenance and construction activities is minimized; oversees and responds to accidents, emergencies, service disruptions, inclement weather, natural disasters, and special events.
- 6. Meets with representatives of the District to ensure safe and efficient revenue operations; coordinates related activities of the Transportation Department with those of other departments and divisions; and coordinates operational activities and special projects to ensure safety standards are met; monitors multiple field locations and oversees and responds to major rail system emergencies 24 hours a day/7 days a week.
- 7. Develops and administers the safety program and related activities and related activities within the Transportation Department for assigned personnel including overseeing the investigation and analysis process for accidents and incidents (as appropriate); implements safety rules, regulations and procedures; develops and disseminates safety bulletins; organizes and schedules safety training workshops.
- 8. Analyzes and evaluates rail operations to determine budgetary impact in the event of service delivery changes; reports findings to Assistant Chief Transportation Officer, Service Delivery and/or other management staff.
- 9. Directs the preparation and submission of a variety of technical and complex reports regarding rail operations.
- 10. Oversees compliance with all federal, state, city and regulatory agency rules, regulations, policies, and procedures; monitors developments and legislation related to assigned area of responsibility; evaluates impact upon district operations; recommends and implements equipment, practice and procedural improvements.
- 11. Oversees and manages performance criteria, goals and evaluation procedures and processes; selects, trains, motivates and evaluates assigned personnel; provides or coordinates staff training; works with employees to correct deficiencies; implements discipline and termination procedures; Actively lead staff to maintain high standards of performance, productivity and competence through clear direction, effective communication, coaching, performance management, training,

development and relationship management to optimize and maintain system performance to provide reliable, safe, cost effective and customer focused service.

- 12. Oversees and participates in the development and administration of the Transportation Department's annual budget and line budget pertaining to staffing and equipment; participates in the forecast of funds needed for staffing, equipment, materials and supplies; monitors and approves expenditures; implements adjustments.
- 13. Serve as the liaison for the Transportation Department with other divisions, departments and outside agencies; negotiates and resolves sensitive and controversial issues; maintains strategic partnerships with government agencies, community organizations, public transit system officials, labor unions and establishes and fosters partnerships with transit peers.
- 14. Serves as staff on a variety of boards, commissions and committees; prepares and presents staff reports and other necessary correspondence.
- 15. Provides staff assistance to the Assistant Chief Transportation Officer, Service Delivery in overseeing and managing objectives, standards, and performance levels for Supervisors, Foreworkers, and Train Operators.
- 16. Conducts a variety of organizational studies, investigations and operational studies; recommends modifications to rail operations programs, policies and procedures as appropriate.
- 17. Attends and participates in professional group meetings; stays abreast of new trends and innovations in the field of rail operations, safety and revenue operations.
- 18. Responds to and resolves difficult and sensitive citizen inquiries and complaints.
- 19. Responds to and coordinates resolution of major delays and incidents in rail service delivery.

- Administrative policies and procedures governing rail operations.
- Principles of transit passenger and employee safety.
- Principles of research, analysis and report preparation.
- Principles and practices of transit revenue operations.
- Principles and practices of construction and maintenance program coordination and administration.
- Principles and practices of budget preparation and administration.
- Principles of supervision, training and performance evaluation.
- Related Federal, State and local laws, codes and regulations.

- Overseeing, directing and coordinating the work of lower level staff.
- Selecting, supervising, training and evaluating staff.
- Participating in the development and administration of division goals, objectives and procedures.
- Preparing and administering large program budgets.
- Preparing clear and concise administrative and financial reports.
- Analyzing problems, identifying alternative solutions, projecting consequences of proposed actions and implementing recommendations in support of goals.
- Researching, analyzing and evaluating new service delivery methods and techniques.
- Directing the development of procedures and standards for train operations.
- Coordinating multiple construction and maintenance programs.
- Assessing budgetary impact of service delivery changes.
- Developing and administering a safety program.
- Interpreting and applying Federal, State and local policies, laws and regulations.
- Communicating clearly and concisely, both orally and in writing.
- Establishing and maintaining effective working relationships with those contacted in the course of the work.

### **MINIMUM QUALIFICATIONS**

### Education:

A Bachelor's degree in business administration, public administration or a closely related field from an accredited college or university.

# Experience:

Five (5) years of (full-time equivalent) verifiable professional experience in rail operations program administration which must have included at least two (2) years of management and/or supervisory experience.

# **Other Requirements:**

Must be physically able to walk wayside on ballast for one mile. Must be physically able to climb aerial structures. Must be physically able to climb two-story stairway to Tower locations.

# Substitution:

Additional professional experience as outlined above may be substituted for the education on a year-foryear basis. A Bachelor's degree is preferred.
