This pilot program will allow bikes on BART, all day on Fridays in August. Grace is looking for volunteers to participate as observers to help in the evaluation of this program.

- Inadequate lighting at Montgomery station around the escalators.

Larry asked for more information regarding operators announcing stops as he feels this is not always happening. He also asked for information regarding the stipend for BATF members. Ike replied that as the newest members to BATF, Larry and Alan will receive their Clipper cards next quarter.
