#### Richmond Garage and Intermodal Project

Paul Plecnik told members that BART has signed up to apply yellow thermoplastic material on each and every stair step nosing on all six levels of the two stairwells in the garage.

Future intermodal modification work will be done under a separate contract in approximately 18 months. At that time, members will be able to have a full accessibility review of the design prior to construction, and at that time, they will be able to address adding yellow dome tiling and curb cutouts on the intermodal adjacent to the garage.

Randall Glock talked about the Fleet of the Future mock-up that was held the day before the BATF meeting. He added that Aaron Weinstein will be coming back in the fall to give members an update on the Fleet of the Future.

Clarence Fischer – fare evasion; would like more patrolling on train by nonuniformed officers and especially in rear cars

Roland Wong – had an experience at Montgomery Station where homeless man urinated in front of him
