1. Self-Introductions of Members, Staff and Guests

2. Public Comments

Chris Mullins reported that there were no working escalators at the 12th Street Station about a week prior. It was a long walk to get to the elevator, and he was quite discouraged.

Ike Nnaji replied that there was door component equipment that was on order.

Members were invited to outreach events at Powell Street Station on 12/16/14 and at Civic Center on 12/18/14 regarding the new canopies being planned. Travel reimbursement has been approved by Bob Franklin.

6. Capital Projects Status Reports

MacArthur Garage

The stair treads for the top three flights have been painted yellow.

Carl Orman has asked the maintenance department about when the stair treads will be cleaned, and if there is a set schedule for cleaning. He will follow up with them and report back to the BATF.

(MacArthur Station) - A request has been made to keep the canopy lights on, especially when it's dark and gloomy.

Station Hearing Loop

Details for The Hearing Loop Demonstration will be given soon.

Oakland Airport Connector

A short discussion was held regarding problems experienced throughout the Oakland Airport Connector.

Some of the things discussed:

- The detectable path of travel, especially on the airport side, is insufficient.

- Concerns regarding the upward ramp from the coliseum to the airport, especially for manual wheelchair users

- Concerns with getting airport assistance from the BART side to the airport.

Bob Franklin stated that he will contact the Port Authority to see what arrangements can be made in order to get people from the Oakland Airport Connector to the Airport, and will report back to the BATF.

General Disability Awareness Brochure

Some final editing and adjustments have been made to the brochure and is now waiting for approval by Chief Rainey.
