1. Call to Order.

2. Call for Quorum.

4. Approval of Minutes of Prior Board Meeting. For Discussion and Action.

5. General Discussion and Public Comment. Limited to 3 minutes per speaker.

6. **BPCRB Training Program.**

a. Use of Force and De-escalation Tactics.

Lieutenant Lopez reviewed BPD Use of Force and De-escalation Tactics, and he and Acting Deputy Chief Haight answered questions from the BPCRB.

7. Chairperson's Report. For Discussion and Action.

Chairperson Garrett congratulated Mr. Bloom on his appointment as the Independent Police Auditor. Ms. Garrett reminded the BPCRB to submit information to Ms. Kidd to include in their next quarterly report. She also mentioned that the BPCRB's review of the Office of Independent Police Auditor will be completed sometime this year.

Ms. Kidd announced that she attended National Night Out at the Ashby BART Station and attended a community healing event.

Mr. Mensinger announced that he attended National Night Out at the Castro Valley BART Station.

8. Chief of Police's Report. For Discussion and Action.

Acting Deputy Chief Haight represented Chief Rainey, who was unable to attending the meeting.

Acting Deputy Chief Haight announced that he attended the National Night Out at the Rockridge and Pittsburg/Bay Point BART Stations.

He restated that BPD is part of the pilot program for Police Executive Research Forum (PERF) use of force and de-escalation training.

Chief Rainey and a contingent of BPD Staff attended the 40th Annual National Organization of Black Law Enforcement Executives (NOBLE) Training Conference in Washington D.C. last month, which discussed best practices and current trends.

Six BPD Officers will attend the 2016 National Asian Peace Officers' Association National Training Symposium and Expo next week in New York.

Acting Deputy Chief Haight attended the funeral service of the Dallas Area Transit Police Officer who lost his life on July 7, 2016. Simultaneously BPD Officers attended the funeral service of one of the Dallas Police Department Officers who was also killed in the same incident. In addition, a BPD Officer attended the Baton Rouge Police Department funeral service of the one of the officers who was killed on July 17, 2016.

a. BPD Monthly Report.

The BPD Monthly Report for May 2016 was distributed to the BPCRB and Acting DC Haight answered questions from the BPCRB.

9. Independent Police Auditor's Report. For Discussion and Action.

a. Office of Independent Police Auditor's Monthly Report.
