BART Police Citizen Review Board Monday, August 14, 2017

A regular meeting of the BART Police Citizen Review Board (BPCRB) was held on Monday, August 14, 2017 convening at 4:00 p.m. in the BART Board Room, 344 20th Street, Oakland, California.

1. Call to Order.

4. Approval of Minutes of Prior Board Meeting. For Discussion and Action.

9. Oversight System Evaluation Report. For Discussion and Action.

Aaron Zisser provided a review of the process for the Oversight System Evaluation Report and categorized the recommendations in the report. Mr. Zisser answered questions from the BPCRB.

A motion to convene a special work session before the next month's BPCRB meeting, to include various stakeholders, so that they may discuss and prioritize the recommendations in the Oversight System Evaluation Report was made by
